§ 1 – General

1. Any private person from the age 18 and an artificial person may register for stand areas including tables and chairs at the Anime Flea Market.
2. For entry to the assembly you have to provide proof of identity (for example identity card, driver's license) and show your stand ticket.
3. The sellers have to bring exchange money by themselves. There is no claim towards the organizers to make this available.
4. The Anime Flea Market provides tablecloth of the German fire protection classification B1 (hardly inflammable) according to DIN 4102 to sellers. Own tablecloths may be used if they conform to the German fire protection classification B1 (hardly inflammable) according to DIN 4102.
5. You have to follow the instructions of the staff of the Anime Flea Market.
6. Contract violations can, depending on their severity, lead to a prohibition of sales or a general exclusion from the Anime Flea Market 2023 and from upcoming events.
7. The organizer reserves the right to exclude sellers from the Anime Flea Market 2023 and upcoming events.

§ 2 – Transferability

1. Stand areas are not transferable to other persons without permission. The resale of a stand ticket is not permitted. Contravention will be punished by a general sales ban on the Anime Flea Market for the next 30 months.
2. You can specify more than one person at registration. One is the contractual partner (the main responsible person). In hindsight, it is possible to set another person from the group indicated at the registration as a contractual partner. With this ruling, a group of people even can get their stand area, if the actual contracting partner of the group should stay away from the event (for example due to illness).
For this change, the previous contractual partner has to write an e-mail to stand@anime-flohmarkt.de so that we can issue you a new stand ticket.

§ 3 – Assembly and dismantling

1. The assembly times are determined by the organizer. A later assembly is not possible. We reserve the right to exclude sellers from the event, if they do not appear at their allotted assembly time.
2. The dismantling times are determined by the organizer. A premature dismantling is not possible and permitted. For safety and fire protection reasons, we will not permit the transport of suitcases and other baggage outside the planned dismantling times in particular.
3. Unsold articles and private goods not intended for sale, for example such as bags, garments, etc., basically have to be taken back. If for any reason something will not be taken along, it is possible to send the items back to the property owner by post. The shipping and packing costs bears the respective property owner.
4. If after two months the property owner of an item had not contact us (for example by e-mail) or had not send the money for possible shipping and packaging costs, the item will be transferred to the property of the organizer.

§ 4 – Stand areas

1. Sellers may only place goods and other items on their respective assigned stand areas. In the context of the recognized customs of the trade, you have also stay on this. It is forbidden to restrict access to other stands or walkways and escape routes.
2. There is also the possibility to handover your single jackets, coats, suitcases, bags etc. at the cloakroom.
3. On the stand areas you may set up other things, such as plug-in shelves or even tables and the like, without additional approvals.
4. It is forbidden to use the sockets of the building, without separately arrangements in advance. Furthermore, no electrical equipment may be connected in general without arrangements with the organizer.
5. The public playing of music and other sounds is prohibited.

§ 5 – Selling

1. The Anime Flea Market is a theme based flea market. At your stand you have to offer mainly articles which have to do with anime/manga or Japan. This includes inter alia also Japanese video games, Japanese music, Japanese cosplay stuff, Japanese clothing, Japanese books (translated books) and Japanese trading card games. Comics, which are not drawn in manga style, movies and books without anime/manga or Japan reference and merchandise articles of this are not subject-related in the sense of the event.
2. It is permitted, to sell additional individual items, which have nothing to do with anime/manga or Japan, if they are clearly identifiable as a minority.
3. It is not allowed to sell items, which violate the law, particularly the copyright (pirated copy, pirated printing etc.). The sale of foodstuffs is only permitted with the additional authorization of the organizer.
4. Self-made and produced items may be sold, if the sale does not violate applicable law, particular copyrights.

5. Goods with age limits may only be sold to people, who providing proof of age.
6. We reserve the right to ask sellers to take individual items from the sale in the event of a violation. In case of serious violations, we reserve the right to exclude sellers from the event.

§ 6 – Limitation of liability

1. The Anime Flea Market resp. the organizer of the Anime Flea Market is liable in accordance with the legal regulations for intent and gross negligence on the part of its legal representatives, volunteers or other vicarious agents. The same applies to the assumption of guarantees or other liability independent of fault as well as to claims under the Product Liability Act or in the event of culpable injury to life, body or health.
2. A further liability of the Anime Flea Market, the organizer of the Anime Flea Market, its legal representatives, volunteers and other vicarious agents is excluded.
3. Should single provisions of these GTC become partially or completely ineffective or void, this shall not affect the effectiveness of the remaining provisions.
4. The user agreement, including these GTC, is subject to German law.

§ 7 – Indemnity against liability

The user discharges the Anime Flea Market, the organizer of the Anime Flea Market, its legal representatives, volunteers and other vicarious agents from all claims that other users or other third parties assert against the Anime Flea Market for violation of their rights by offers and other contents posted by the user by means of the services of the Anime Flea Market or because of their other use of the services of the Anime Flea Market. The user accepts the costs of the necessary defense of the Anime Flea Market, including all legal fees and costs of the proceedings in the legal amount. This is not valid if the
